Part V: Vehicle

You may calculate your deduction using either of two methods: *actual expense method* or *the standard mileage method*. Regardless, the IRS requires a thorough, contemporaneous, written mileage log. We will use the **mileage deduction rate of \$0.575 per mile for tax year 2015.** This rate accounts for gas, repairs, maintenance, depreciation, and auto insurance (but not interest on a car loan or car tag).
